Dear Shri Nitish Mishra ji,

Please refer to your letter Ref. No. 33/2021 dated 11.01.2021 and this Ministry's D.O. letter No. MoPNG/2021/138390 dated 28.1.2021 regarding implementation of SATAT Scheme in Jhanjharpur, Bihar.

2. I would like to inform that Sustainable Alternative Towards Affordable Transportation (SATAT) was launched by Ministry of Petroleum and Natural Gas to create an ecosystem for production of Compressed Bio Gas (CBG) from various waste/ biomass sources in the country.

3. Under SATAT scheme, Oil and Gas Marketing Companies (IOCL, BPCL, HPCL, GAIL and IGL) are inviting Expression of Interest (Eoi) to procure CBG from potential entrepreneurs for procurement of CBG. Any entrepreneur can apply for setting up of a CBG Plant in Jhanjharpur, Bihar by participating in Eoi. Eoi can be accessed from IndianOil website (<https://iocletenders.nic.in/nicgep/app>); BPCL website (www.bharatpetroleum.com/); HPCL website (www.hindustanpetroleum.com) and GAIL website (www.gailonline.com) under tenders and contracts.

4. I am glad to inform that Oil and Gas Marketing companies have already awarded 14 Letters of Intent for setting up CBG Plants in Aurangabad, Bhagalpur, Champaran, Gopalganj, Muzaffarpur, Patna and Rohtas. Further, IndianOil has been advised to suitably publicize the SATAT initiative in Bihar to explore possibilities of setting up CBG plant in Jhanjharpur.

5. I firmly believe that with your support, more such CBG plants would come up in Bihar including Jhanjharpur.
